Sealed tenders are invited on behalf of the Director, GSDS from interested parties to operate two basic refreshment Kiosks (Canteens), one of size of "17 sqm area approx" at Gandhi Smriti, 5-Tees January Marg, New Delhi and other of size "50 sq.metre area approx" at Gandhi Darshan, Near Rajghat, New Delhi, for operating basic refreshment Kiosks (Canteens)/ food and beverage outlet, strictly vegetarian items, subject to the terms and conditions enclosed.

The contract will be for a period of 11 month and can be terminated by the Samiti, after giving a notice of 1 month, if the services are not found satisfactory.

Bids of the tenderer will be opened by giving information to the tenderers, who may like to be present. Director , GSDS , New Delhi reserves the right to accept or reject any or all the tenders without assigning any reason whatsoever thereof.

A committee constituted by GSDS for this purpose will shortlist the items offered by the parties as per requirement of the Samiti and samples of the selected/shortlisted items will be checked by this committee and on the basis approval of the samples & on L1 basis, the tender will be finalized.

Terms and Conditions

1. The bidder will be required to purchase tender document and submit the bid by mentioning on the envelope "Application for basic refreshment Kiosks (Canteens) at Gandhi Smriti / Gandhi Darshan. **Please mention contact detail and Email ID of the bidder.**

2. **Location of basic refreshment Kiosks (Canteens):**

**(1) Gandhi Smriti, 5 Tees January Marg, New Delhi
measuring: (17 sq.mtr)**

**(2) Gandhi Darshan, Rajghat, New Delhi
Measuring (50 sq.mtr) approx**

The contractor herein will be called as licensee and GSDS as Licensor. The Licensee shall use the said licensed premises only for the purpose of operating a strictly vegetarian refreshment, snacks and mineral water inside the (1)Gandhi Smriti, 5, Tees January Marg, New Delhi, and (2) Gandhi Darshan, Rajghat, New Delhi subject to the terms and conditions, the guidelines and policies framed by the Licensor from time to time and for no other purpose (hereinafter referred to as "Permitted Purpose"). Apart from licensed premises, no other area adjacent to Canteen inside Gandhi Smriti, and Gandhi Darshan shall be used by the Licensee.

3. The interested parties giving the contract for operating basic refreshment Kiosks (Canteens) in (1) Gandhi Smriti, 5-Tees January Marg which will facilitate our Campus, staff and visitors. There is basic refreshment Kiosks (Canteens) of size '17 sqm' for which sealed quotations are invited. The Licensee shall pay the License fee @ Rs. 800/- per sqm as per Order NO.18015/1/2017-Pol.III, dated 10.06.2020, issued by the Ministry of Housing and Urban Development, Directorate of Estate for the canteen occupation area 17 sqm. Total License Fee per month is Rs. 13,600/-.
4. and (2) Gandhi Darshan, Rajghat, There is basic refreshment Kiosks (Canteens) of sizes '50 sqm' for which sealed quotations are invited. The Licensee shall pay the License fee @ Rs. 800/- per sqm as per Order NO.18015/1/2017-Pol.III, dated 10.06.2020, issued by the Ministry of Housing and Urban Development, Directorate of Estate for the canteen occupation area 50 sqm. Total License Fee per month is Rs. 40,000/-.
1. The above mentioned fee for the said premises will have to be paid on half yearly basis (for six months) on the accrual basis in advance before the 7th day of the month. Electricity and Water charges will be payable monthly by the licensee as per actual monthly consumption for which a separate sub-meter will be installed. The Electricity & Water Charges shall be payable by the Licensee before the 7th day of every month. In the event of the license

being revoked or terminated, the Licensee shall pay a proportionate part of the license fee at the rate in force including the proportionate charge for water consumption, electricity, etc. In case the Licensee fails to deposit the license fee, water charges, electricity bill, etc. within the specified period, otherwise, interest @ 18% per annum shall be charged for the same from the Licensee on the due amount. However, it shall be the responsibility of the Licensee to get all dues clearance from the appropriate authority before handing over the vacant charge of the premises otherwise the same will be recovered by the GSDS.

5. The contract will be for a period of 11 months and can be terminated after giving notice of 1 month, if the services are not found satisfactory.
6. There will be EMD of Rs.25000/- for each canteen. The EMD amount of Rs.25,000/- of successful bidders will be deposited as security amount which is refundable on expiry of the contract period of eleven months.
7. Timing for running the Canteen will be from 9.30 a.m. to 5.30 p.m., apart from this half-an-hour will be given in making preparation and arranging material both at the time of opening and closing. The Canteen will be operative only on working days.
8. Non-Vegetarian foods, hard drinks, intoxicants, cigarette, gutka, etc. of any kind are strictly prohibited in the Canteen. No advertisement of any private agency or company will be displaced anywhere nearby area or on the walls of the Kiosks.
9. **Snacks/tea/coffee etc. sold to the employees of the Samiti should be on subsidised rates to be fixed mutually.**
10. The licensee will be exclusively responsible for cleaning of the surrounding area of Canteen.
11. The licensee may without assigning any reason, surrender the licence after giving one month prior written notice to the licensor after clearing all dues. In that case his Earnest Money will be forfeited.
12. The licensee shall reimburse any loss or damage to the property and others.
13. On successful completion of 11 (eleven) month of Licence, and on the basis of mutual agreement between the GSDS and the licensee, the licence can be renewed for a further period of 11 months on year to year basis on mutually agreed terms.
14. A fresh agreement and affidavit will be signed at the time of every renewal of the Licence.
15. The cost of electricity and water will be paid by the licensee. Electrical & water connection will be provided by the GSDS against meter charges payable to the GSDS.
16. Water shall be provided by the GSDS against minimum charges of Rs. 100/- month.

17. The bidders may inspect the canteen area by giving proper information to GSDS on any working days.
18. Bidders should send their bid in the separate sealed covers and clearly mark "**Bid for refreshment Kiosks (Canteens)**", at Gandhi Smriti, Tees January Marg, New Delhi and "**Bid for refreshment Kiosks (Canteens)**", at Gandhi Darshan, Rajghat, New Delhi the name of the bidder clearly written with full address, email id, if any and telephone numbers on it. The envelop should be addressed to the Administrative Officer, Gandhi Smriti and Darshan Samiti, Gandhi Darshan, Rajghat, New Delhi.
